UNANIMOUS CONSENT AGREEMENTS

S. 3853

1.—Ordered, That at a time to be determined by the Majority Leader, in consultation with the Republican Leader, but no later than Friday, March 8, 2024, the Senate proceed to the consideration of S. 3853, a bill to extend the period for filing claims under the Radiation Exposure Compensation Act and to provide for compensation under such Act for claims relating to Manhattan Project waste, and to improve compensation for workers involved in uranium mining; provided, that there be up to one hour for debate, equally divided between the two Leaders or their designees, and that upon use or yielding back of time, the bill be considered read a third time, and the Senate vote on passage of the bill, without intervening action or debate, with 60 affirmative votes required for passage. (February 29, 2024.)

S.J. RES. 4 (ORDER NO. 3)

2.—Ordered, That with respect to the motion to invoke cloture on the motion to proceed to S.J. Res. 4, a joint resolution removing the deadline for the ratification of the Equal Rights Amendment, the mandatory quorum call under Rule XXII be waived. (April 25, 2023.)

S. 326 (ORDER NO. 32)

3.—Ordered, That with respect to the motion to invoke cloture on the motion to proceed to S. 326, a bill to direct the Secretary of Veterans Affairs to carry out a study and clinical trials on the effects of cannabis on certain health outcomes of veterans with chronic pain and post-traumatic stress disorder, and for other purposes, the mandatory quorum call under Rule XXII be waived. (April 20, 2023.)
