UNANIMOUS CONSENT AGREEMENTS

S.J. RES. 62 (ORDER NO. 340)

1.—Ordered, That on Thursday, March 21, 2024, upon disposition of the Rodriguez nomination, the Senate resume Legislative Session for the consideration of S.J. Res. 62, a joint resolution providing for congressional disapproval under chapter 8 of title 5, United States Code, of the rule submitted by the Animal and Plant Health Inspection Service relating to "Importation of Fresh Beef From Paraguay"; provided, that the motion to proceed be agreed to and the Senate immediately vote on passage of the joint resolution. (March 20, 2024.)

S.J. RES. 4 (ORDER NO. 3)

2.—Ordered, That with respect to the motion to invoke cloture on the motion to proceed to S.J. Res. 4, a joint resolution removing the deadline for the ratification of the Equal Rights Amendment, the mandatory quorum call under Rule XXII be waived. (April 25, 2023.)

S. 326 (ORDER NO. 32)

3.—Ordered, That with respect to the motion to invoke cloture on the motion to proceed to S. 326, a bill to direct the Secretary of Veterans Affairs to carry out a study and clinical trials on the effects of cannabis on certain health outcomes of veterans with chronic pain and post-traumatic stress disorder, and for other purposes, the mandatory quorum call under Rule XXII be waived.
