UNANIMOUS CONSENT AGREEMENTS

S.J. RES. 61 (ORDER NO. 359)

1.—*Ordered*, That on Wednesday, April 10, 2024, upon disposition of the Allen nomination, the Senate resume Legislative Session and proceed to the consideration of S.J. Res. 61, a joint resolution providing for congressional disapproval under chapter 8 of title 5, United States Code, of the rule submitted by the Federal Highway Administration relating to “National Performance Management Measures; Assessing Performance of the National Highway System, Greenhouse Gas Emissions Measure”; provided, that at 2:45 p.m., the joint resolution be considered read a third time and the Senate vote on passage of the joint resolution. (*April 9, 2024.*)

H.J. RES. 98

2.—*Ordered*, That on Wednesday, April 10, 2024, upon disposition of S.J. Res. 61, the Senate proceed to the immediate consideration of H.J. Res. 98, a joint resolution providing for congressional disapproval under chapter 8 of title 5, United States Code, of the rule submitted by the National Labor Relations Board relating to “Standard for Determining Joint Employer Status”; provided, that at 5:00 p.m., the joint resolution be considered read a third time and the Senate vote on passage of the joint resolution. (*April 9, 2024.*)

S. 4072 (ORDER NO. 350)

3.—*Ordered*, That notwithstanding Rule XXII, at a time to be determined by the Majority Leader in consultation with the Republican Leader, but no later than Friday, April 19, 2024, the Senate proceed to the consideration of S. 4072, a bill to prohibit the use of funds to implement, administer, or enforce certain rules of the Environmental Protection Agency; provided, that there be up to two hours for debate equally divided, and upon use or yielding back of time, the bill be considered read a third time and the Senate vote on passage of the bill with 60 affirmative votes required for passage, without intervening action or debate; provided further, that if the bill is passed, the motion to reconsider be considered made and laid upon the table. (*March 22, 2024.*)

S.J. RES. 4 (ORDER NO. 3)

4.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S.J. Res. 4, a joint resolution removing the deadline for the ratification of the Equal Rights Amendment, the mandatory quorum call under Rule XXII be waived. (*April 25, 2023.*)

S. 326 (ORDER NO. 32)

5.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 326, a bill to direct the Secretary of Veterans Affairs to carry out a study and clinical trials on the effects of cannabis on certain health outcomes of veterans with chronic pain and post-traumatic stress disorder, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*April 20, 2023.*)
