### UNANIMOUS CONSENT AGREEMENTS

### H.R. 3935 (ORDER NO. 211)

1.—Ordered, That on Tuesday, April 23, 2024, upon the conclusion of Morning Business, the Senate resume consideration of the motion to proceed to H.R. 3935, an Act to amend title 49, United States Code, to reauthorize and improve the Federal Aviation Administration and other civil aviation programs, and for other purposes. (April 20, 2024.)

### HOUSE MESSAGE TO ACCOMPANY H.R. 815

2.—Ordered, That when the Senate receives a message from the House to accompany H.R. 815, an Act to amend title 38, United States Code, to make certain improvements relating to the eligibility of veterans to receive reimbursement for emergency treatment furnished through the Veterans Community Care program, and for other purposes, and if the Senator from New York (Mr. Schumer), or his designee, requests that the Chair lay the message before the Senate without intervening action or debate; provided, that if a motion to invoke cloture is filed with respect to the message, it ripen upon disposition of a motion to table a pending amendment or motion made by the Senator from Utah (Mr. Lee) or designee, or at 1:00 p.m. on Tuesday, April 23, 2024; provided further, that if a motion to invoke cloture is filed on the House message to accompany H.R. 815, the filing deadline for first-degree amendments be at 12:00 noon on Tuesday, April 23, 2024. (April 20, 2024.)

### S.J. RES. 4 (ORDER NO. 3)

3.—Ordered, That with respect to the motion to invoke cloture on the motion to proceed to S.J. Res. 4, a joint resolution removing the deadline for the ratification of the Equal Rights Amendment, the mandatory quorum call under Rule XXII be waived. (April 25, 2023.)

### S. 326 (ORDER NO. 32)

4.—Ordered, That with respect to the motion to invoke cloture on the motion to proceed to S. 326, a bill to direct the Secretary of Veterans Affairs to carry out a study and clinical trials on the effects of cannabis on certain health outcomes of veterans with chronic pain and post-traumatic stress disorder, and for other purposes, the mandatory quorum call under Rule XXII be waived. (April 20, 2023.)
