UNANIMOUS CONSENT AGREEMENTS

H.R. 3935 (ORDER NO. 211)

1.—Ordered, That on Thursday, May 2, 2024, upon the conclusion of Morning Business, the Senate resume consideration of the motion to proceed to H.R. 3935, an Act to amend title 49, United States Code, to reauthorize and improve the Federal Aviation Administration and other civil aviation programs, and for other purposes; provided, that all post-cloture time be considered expired at 1:45 p.m. (May 1, 2024.)

2.—Ordered, That if the Senate receives a message from the House of Representatives that it has passed H.R. 7791, a bill to amend the Internal Revenue Code of 1986 to postpone tax deadlines and reimburse paid late fees for United States nationals who are unlawfully or wrongfully detained or held hostage abroad, and for other purposes, and if the text is identical to S. 4057, a bill to amend the Internal Revenue Code of 1986 to postpone tax deadlines and reimburse paid late fees for United States nationals who are unlawfully or wrongfully detailed or held hostage abroad, and for other purposes, H.R. 7791 be considered as having been read three times and passed, and the motion to reconsider be considered made and laid upon the table.
