UNANIMOUS CONSENT AGREEMENTS

H.R. 7791

1.—Ordered, That if the Senate receives a message from the House of Representatives that it has passed H.R. 7791, a bill to amend the Internal Revenue Code of 1986 to postpone tax deadlines and reimburse paid late fees for United States nationals who are unlawfully or wrongfully detained or held hostage abroad, and for other purposes, and if the text is identical to S. 4057, a bill to amend the Internal Revenue Code of 1986 to postpone tax deadlines and reimburse paid late fees for United States nationals who are unlawfully or wrongfully detailed or held hostage abroad, and for other purposes, H.R. 7791 be considered as having been read three times and passed, and the motion to reconsider be considered made and laid upon the table.
