## UNANIMOUS CONSENT AGREEMENTS

### HOUSE MESSAGE TO ACCOMPANY S. 2073

1.—*Ordered*, That on Thursday, July 25, 2024, following the conclusion of Morning Business, the Senate resume consideration of the House Message to Accompany S. 2073, an Act to amend title 31, United States Code, to require agencies to include a list of outdated or duplicative reporting requirements in annual budget justifications, and for other purposes; provided, that notwithstanding Rule XXII, the motion to invoke cloture on the motion to concur in the House amendment to S. 2073 with Amdt. No. 3021, offered by the Senator from New York (Mr. Schumer), ripen at 2:15 p.m.; provided further, that the mandatory quorum call under Rule XXII be waived. (*July 24, 2024.*)

#### S. 4554 (ORDER NO. 420)

2.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 4554, a bill to express support for protecting access to reproductive health care after the *Dobbs v. Jackson* decision on June 24, 2022, the mandatory quorum call under Rule XXII be waived. (*July 10, 2024.*)

#### S. 4381 (ORDER NO. 400)

3.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 4381, a bill to protect an individual's ability to access contraceptives and to engage in contraception and to protect a health care provider's ability to provide contraceptives, contraception, and information related to contraception, the mandatory quorum under Rule XXII be waived. (*June 5, 2024.*)

#### H.R. 7791

4.—*Ordered*, That if the Senate receives a message from the House of Representatives that it has passed H.R. 7791, a bill to amend the Internal Revenue Code of 1986 to postpone tax deadlines and reimburse paid late fees for United States nationals who are unlawfully or wrongfully detained or held hostage abroad, and for other purposes, and if the text is identical to S. 4057, a bill to amend the Internal Revenue Code of 1986 to postpone tax deadlines and reimburse paid late fees for United States nationals who are unlawfully or wrongfully detained or held hostage abroad, and for other purposes, H.R. 7791 be considered as having been read three times and passed, and the motion to reconsider be considered made and laid upon the table. (*April 30, 2023.*)

#### S.J. RES. 4 (ORDER NO. 3)

5.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S.J. Res. 4, a joint resolution removing the deadline for the ratification of the Equal Rights Amendment, the mandatory quorum call under Rule XXII be waived. (*April 25, 2023.*)

#### S. 326 (ORDER NO. 32)

6.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 326, a bill to direct the Secretary of Veterans Affairs to carry out a study and clinical trials on the effects of cannabis on certain health outcomes of veterans with chronic pain and post-traumatic stress disorder, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*April 20, 2023.*)
