UNANIMOUS CONSENT AGREEMENTS

HOUSE MESSAGE TO ACCOMPANY H.R. 5009

1.—*Ordered*, That on Wednesday, December 18, 2024, all post-cloture time on the motion to concur in the House amendment to the Senate amendment to H.R. 5009, an Act to reauthorize wildlife habitat and conservation programs, and for other purposes, be considered expired at 11:45 a.m. (*December 17, 2024.*)

H.R. 82 (ORDER NO. 693)

2.—*Ordered*, That on Wednesday, December 18, 2024, upon disposition of the House message to accompany H.R. 5009, the Senate resume consideration of the motion to proceed to H.R. 82, an Act to amend title II of the Social Security Act to repeal the Government pension offset and windfall elimination provisions; provided, that the cloture motion with respect to the motion to proceed to ripen at 2:00 p.m. (*December 17, 2024.*)

HOUSE MESSAGE TO ACCOMPANY S. 4367

3.—*Ordered*, That at a time to be determined by the Majority Leader in consultation with the Republican Leader and notwithstanding Rule XXII, the Chair lay before the Senate the House message to accompany S. 4367, an Act to provide for improvements to the rivers and harbors of the United States, to provide for the conservation and development of water and related resources, and for other purposes; provided, that the Majority Leader, or his designee, be recognized to make a motion to concur in the House amendment to S. 4367 and there be up to one hour of debate, equally divided, on the motion to concur; provided further, that upon use or yielding back of time, the Senate vote on the motion to concur in the House amendment to S. 4367, with 60 affirmative votes required for adoption of the motion to concur; further, that no other motions or amendments be in order. (*December 12, 2024.*)

H.R. 1555 (ORDER NO. 457)

4.—*Ordered*, That the motion to invoke cloture on the motion to proceed to H.R. 1555, an Act to designate the facility of the United States Postal Service located at 2300 Sylvan Avenue in Modesto, California, as the “Corporal Michael D. Anderson Jr. Post Office Building” ripen at a time to be determined by the Majority Leader in consultation with the Republican Leader no later than September 26, 2024; provided, that the mandatory quorum call under Rule XXII be waived. (*September 19, 24, 2024.*)

H.R. 9614

5.—*Ordered*, That if the Senate receives H.R. 9614, a bill to amend the Internal Revenue Code of 1986 to make certain provisions with respect to qualified ABLE programs permanent, from the House of Representatives, the text of which is identical to S. 4539, a bill to amend the Internal Revenue Code of 1986 to make certain provisions with respect to qualified ABLE programs permanent, the Senate proceed to its immediate consideration, the bill be considered read a third time and passed, and the motion to reconsider be considered made and laid upon the table. (*September 19, 2024.*)

S. 4381 (ORDER NO. 400)

6.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 4381, a bill to protect an individual’s ability to access contraceptives and to engage in contraception and to protect a health care provider’s ability to provide contraceptives, contraception, and information related to contraception, the mandatory quorum under Rule XXII be waived. (*June 5, 2024.*)

H.R. 7791

7.—*Ordered*, That if the Senate receives a message from the House of Representatives that it has passed H.R. 7791, a bill to amend the Internal Revenue Code of 1986 to postpone tax deadlines and reimburse paid late fees for United States nationals who are unlawfully or wrongfully detained or held hostage abroad, and for other purposes, and if the text is identical to S. 4057, a bill to amend the Internal Revenue Code of 1986 to postpone tax deadlines and reimburse paid late fees for United States nationals who are unlawfully or wrongfully detailed or held hostage abroad, and for other purposes,

H.R. 7791 be considered as having been read three times and passed, and the motion to reconsider be considered made and laid upon the table. (*April 30, 2023.*)

S.J. RES. 4 (ORDER NO. 3)

8.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S.J. Res. 4, a joint resolution removing the deadline for the ratification of the Equal Rights Amendment, the mandatory quorum call under Rule XXII be waived. (*April 25, 2023.*)

S. 326 (ORDER NO. 32)

9.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 326, a bill to direct the Secretary of Veterans Affairs to carry out a study and clinical trials on the effects of cannabis on certain health outcomes of veterans with chronic pain and post-traumatic stress disorder, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*April 20, 2023.*)
