H.R. 144.—	To provide that the Federal Reports Elimination and Sunset Act of 1995 does not apply to certain reports required to be submitted by the Tennessee Valley Authority, and for other purposes. Referred to Transportation and Infrastructure Jan. 3, 2025. Considered under suspension of rules Jan. 13, 2025.		
H.R. 152.—	To amend the Disaster Recovery Reform Act of 2018 to develop a study regarding streamlining and consolidating information collection and preliminary damage assessments, and for other purposes. Referred to Transportation and Infrastructure Jan. 3, 2025. Rules suspended. Passed House Jan. 13, 2025; Roll No. 9: 405–5.		
H.R. 153.—	To provide for an online repository for certain reporting requirements for recipients of Federal disaster assistance, and for other purposes. H.R. 164.—	To amend the Robert T. Stafford Disaster Relief and Emergency Assistance Act to authorize Federal agencies to provide certain essential assistance for hazard mitigation for electric utilities, and for other purposes.
