Referred to Transportation and Infrastructure Jan. 3, 2025. Rules suspended. Passed House Jan. 13, 2025.
H.R. 28.—	To amend the Education Amendments of 1972 to provide that for purposes of determining compliance with title IX of such Act in athletics, sex shall be recognized based solely on a person's reproductive biology and genetics at birth. Referred to Education and Workforce Jan. 3, 2025. Passed House Jan. 14, 2025; Roll No. 12: 218–206.	H.R. 192.—	To amend title 49, United States Code, to require Amtrak to include information on base pay and bonus compensation of certain Amtrak executives, and for other purposes. Referred to Transportation and Infrastructure Jan. 3, 2025. Rules suspended. Passed House Jan. 13, 2025; Roll No. 8: 407–0.
H.R. 29 (H. Res. 5) (S. 5).—	To require the Secretary of Homeland Security to take into custody aliens who have been charged in the United States with theft, and for other purposes. Referred to the Judiciary Jan. 3, 2025. Passed House Jan. 7, 2025; Roll No. 6: 264–159. Received in Senate Jan. 8, 2025.		
H.R. 144.—	To provide that the Federal Reports Elimination and Sunset Act of 1995 does not apply to certain reports required to be submitted by the Tennessee Valley Authority, and for other purposes. Referred to Transportation and Infrastructure Jan. 3, 2025. Considered under suspension of rules Jan. 13, 2025.		
H.R. 152.—	To amend the Disaster Recovery Reform Act of 2018 to develop a study regarding streamlining and consolidating information collection and preliminary damage assessments, and for other purposes. Referred to Transportation and Infrastructure Jan. 3, 2025. Rules suspended. Passed House Jan. 13, 2025; Roll No. 9: 405–5.		
H.R. 153.—	To provide for an online repository for certain reporting requirements for recipients of Federal disaster assistance, and for other purposes. Referred to Transportation and Infrastructure and in addition to Small Business, and Financial Services Jan. 3, 2025. Considered under suspension of rules Jan. 13, 2025. Rules suspended. Passed House Jan. 14, 2025; Roll No. 10: 426–0.		
H.R. 164.—	To amend the Robert T. Stafford Disaster Relief and Emergency Assistance Act to authorize Federal agencies to provide certain essential assistance for hazard mitigation for electric utilities, and for other purposes. Referred to Transportation and Infrastructure Jan. 3, 2025. Considered under suspension of rules Jan. 13, 2025.
