Res. 5).— To impose sanctions with respect to the International Criminal Court engaged in any effort to investigate, arrest, detain, or prosecute any protected person of the United States and its allies. Referred to Foreign Affairs and in addition to the Judiciary, and Appropriations Jan. 3, 2025. Passed House Jan. 9, 2025; Roll No. 7: 243–140. Received in Senate Jan. 9, 2025. Ordered placed on the calendar Jan. 13, 2025.</p> <p>H.R. 28 (H. Res. 5).— To amend the Education Amendments of 1972 to provide that for purposes of determining compliance with title IX of such Act in athletics, sex shall be recognized based solely on a person’s reproductive biology and genetics at birth. Referred to Education and Workforce Jan. 3, 2025. Passed House Jan. 14, 2025; Roll No. 12: 218–206. Received in Senate Jan. 15, 2025.</p> <p>H.R. 29 (H. Res. 5) (S. 5).— To require the Secretary of Homeland Security to take into custody aliens who have been charged in the United States with theft, and for other purposes. Referred to the Judiciary Jan. 3, 2025. Passed House Jan. 7, 2025; Roll No. 6: 264–159. Received in Senate Jan. 8, 2025.</p> <p>H.R. 30 (H. Res. 5).— To amend the Immigration and Nationality Act to provide that aliens who have been convicted of or who have committed sex offenses or domestic violence are inadmissible and deportable. Referred to the Judiciary Jan. 3, 2025. Passed House Jan. 16, 2025; Roll No. 17: 274–145.</p> <p>H.R. 33 (H. Res. 5).— To amend the Internal Revenue Code of 1986 to provide special rules for the taxation of certain residents of Taiwan with income from sources within the United States. Referred to Ways and Means and in addition to Rules Jan. 3, 2025. Passed House Jan. 15, 2025; Roll No. 15: 423–1.</p> <p>H.R. 144.— To provide that the Federal Reports Elimination and Sunset Act of 1995 does not apply to certain reports required to be submitted by the Tennessee Valley Authority, and for other purposes. Referred to Transportation and Infrastructure Jan. 3, 2025. Considered under suspension of rules Jan. 13, 2025. Rules suspended. Passed House Jan. 15, 2025; Roll No. 14: 423–0.</p>	<p>H.R. 152.— To amend the Disaster Recovery Reform Act of 2018 to develop a study regarding streamlining and consolidating information collection and preliminary damage assessments, and for other purposes. Referred to Transportation and Infrastructure Jan. 3, 2025. Rules suspended. Passed House Jan. 13, 2025; Roll No. 9: 405–5. Received in Senate and referred to Homeland Security and Governmental Affairs Jan. 14, 2025.</p> <p>H.R. 153.— To provide for an online repository for certain reporting requirements for recipients of Federal disaster assistance, and for other purposes. Referred to Transportation and Infrastructure and in addition to Small Business, and Financial Services Jan. 3, 2025. Considered under suspension of rules Jan. 13, 2025. Rules suspended. Passed House Jan. 14, 2025; Roll No. 10: 426–0. Received in Senate and referred to Homeland Security and Governmental Affairs Jan. 15, 2025.</p> <p>H.R. 164.— To amend the Robert T. Stafford Disaster Relief and Emergency Assistance Act to authorize Federal agencies to provide certain essential assistance for hazard mitigation for electric utilities, and for other purposes. Referred to Transportation and Infrastructure Jan. 3, 2025. Considered under suspension of rules Jan. 13, 2025. Rules suspended. Passed House Jan. 15, 2025; Roll No. 13: 419–2.</p> <p>H.R. 189.— To amend title 40, United States Code, to eliminate the leasing authority of the Securities and Exchange Commission, and for other purposes. Referred to Transportation and Infrastructure Jan. 3, 2025. Rules suspended. Passed House Jan. 13, 2025. Received in Senate and referred to Banking, Housing, and Urban Affairs Jan. 14, 2025.</p> <p>H.R. 192.— To amend title 49, United States Code, to require Amtrak to include information on base pay and bonus compensation of certain Amtrak executives, and for other purposes. Referred to Transportation and Infrastructure Jan. 3, 2025. Rules suspended. Passed House Jan. 13, 2025; Roll No. 8: 407–0. Received in Senate and referred to Commerce, Science and Transportation Jan. 14, 2025.</p>
