Ordered placed on the calendar Jan. 7, 2025. Considered Jan. 13, 14, 15, 16, 17, 2025. Passed Senate amended Jan. 20, 2025; Roll No. 7: 64-35. Received in House and held at desk Jan. 21, 2025. Passed House Jan. 22, 2025; Roll No. 23: 263-156. Presented to the President Jan. 23, 2025. Approved Jan. 29, 2025. Public Law 119-1.		
S. 6.—	To amend title 18, United States Code, to prohibit a health care practitioner from failing to exercise the proper degree of care in the case of a child who survives an abortion or attempted abortion. Ordered placed on the calendar Jan. 16, 2025.		
S. 9.—	To provide that for purposes of determining compliance with title IX of the Education Amendments of 1972 in athletics, sex shall be recognized based solely on a person's reproductive biology and genetics at birth. Ordered placed on the calendar Jan. 8, 2025.		
S. 32.—	To clarify where court may be held for certain district courts in Texas and California. Referred to the Judiciary Jan. 8, 2025. Committee discharged. Passed Senate Feb. 12, 2025. Received in House and held at desk Feb. 13, 2025.		
S. 68.—	To prohibit the suspension of collections on loans made to small businesses related to COVID-19, and for other purposes. Referred to Small Business and Entrepreneurship Jan. 9, 2025. Reported amended Feb. 10, 2025; no written report.		
S. 273.—	To allow nonprofit child care providers to participate in certain loan programs of the Small Business Administration, and for other purposes. Referred to Small Business and Entrepreneurship Jan. 28, 2025. Reported amended Feb. 10, 2025; no written report.		
S. 347.—	To amend the Comprehensive Environmental Response, Compensation, and Liability Act of 1980 to reauthorize brownfields revitalization funding, and for other purposes. Referred to Environment and Public Works Jan. 30, 2025. Reported Feb. 5, 2025; no written report.		
S. 351.—	To establish a pilot grant program to improve recycling accessibility, to require the Administrator of the Environmental Protection Agency to carry out certain activities to collect and disseminate data on recycling and composting programs in the United States, and for other purposes. Referred to Environment and Public Works Jan. 30, 2025. Reported Feb. 5, 2025; no written report.
