Ordered placed on the calendar Jan. 16, 2025.</p> <p>S. 9.— To provide that for purposes of determining compliance with title IX of the Education Amendments of 1972 in athletics, sex shall be recognized based solely on a person's reproductive biology and genetics at birth. Ordered placed on the calendar Jan. 8, 2025.</p> <p>S. 32.— To clarify where court may be held for certain district courts in Texas and California. Referred to the Judiciary Jan. 8, 2025. Committee discharged. Passed Senate Feb. 12, 2025. Received in House and held at desk Feb. 13, 2025.</p> <p>S. 68.— To prohibit the suspension of collections on loans made to small businesses related to COVID-19, and for other purposes.
