UNANIMOUS CONSENT AGREEMENTS**S. 6 (ORDER NO. 4)**

1.—*Ordered*, That on Wednesday, January 22, 2025, the Senate resume consideration of the motion to proceed to S. 6, a bill to amend title 18, United States Code, to prohibit a health care practitioner from failing to exercise the proper degree of care in the case of a child who survives an abortion or attempted abortion; provided, that with respect to the motion to invoke cloture on the motion to proceed, the mandatory quorum call under Rule XXII be waived; provided further, that the Senate vote on the motion to invoke cloture on the motion to proceed at 2:30 p.m. (*January 20, 21, 2025.*)
