UNANIMOUS CONSENT AGREEMENTS**S.J. RES. 10**

1.—*Ordered*, That upon the conclusion of Morning Business on Wednesday, February 26, 2025, the Committee on Energy and Natural Resources be discharged from further consideration of S.J. Res. 10, a joint resolution terminating the national emergency declared with respect to energy, and the Senate proceed to its consideration; provided, that there be 6 hours for debate only with the time equally divided between the Leaders, or their designees, on the joint resolution; provided further, that following confirmation of the Greer nomination, the Senate resume consideration of the joint resolution; further, that following the use or yielding back of time, the joint resolution be read a third time, and the Senate vote on the joint resolution, with no intervening action or debate.
