UNANIMOUS CONSENT AGREEMENTS

S. 331 (ORDER NO. 18)

1.—*Ordered*, That on Friday, March 14, 2025, upon disposition of the Feinberg nomination, the Senate resume consideration of S. 331, a bill to amend the Controlled Substances Act with respect to the scheduling of fentanyl-related substances, and for other purposes; provided, that all post-cloture time be expired, and Amdt. No. 1237, offered by the Senator from South Dakota (Mr. Thune) for the Senator from Iowa (Mr. Grassley) be withdrawn; provided further, that the bill be read a third time, and the Senate vote on passage of the bill; further, that if passed, the motion to reconsider be considered made and laid upon the table with no intervening action or debate. (*Mar. 13, 2025.*)

H.R. 1968 (ORDER NO. 26)

2.—*Ordered*, That on Friday, March 14, 2025, following disposition of S. 331, the Senate vote on the motion to invoke cloture on the motion to proceed to H.R. 1968, an Act making further continuing appropriations and other extensions for the fiscal year ending September 30, 2025, and for other purposes.
