**UNANIMOUS CONSENT AGREEMENTS****S.J. RES. 18 (ORDER NO. 34)**

1.—*Ordered*, That on Thursday, March 27, 2025, notwithstanding Rule XXII, upon the conclusion of Morning Business, the Senate resume consideration of S.J. Res. 18, a joint resolution disapproving the rule submitted by the Bureau of Consumer Financial Protection relating to “Overdraft Lending: Very Large Financial Institutions”; provided, that at 11:20 a.m., the Senate vote on passage of the joint resolution. (*Mar. 26, 2025.*)

**S.J. RES. 37**

2.—*Ordered*, That notwithstanding Rule XXII, at a time to be determined by the Majority Leader, in consultation with the Democratic Leader, and no earlier than Tuesday, April 1, 2025, S.J. Res. 37, a joint resolution terminating the national emergency declared to impose duties on articles imported from Canada, be discharged from the Committee on Finance and the Senate proceed to its consideration; provided, that there be six hours for debate only, with the time equally divided between the Leaders and their designees; provided further, that following the use or yielding back of that time, the joint resolution be read a third time and the Senate vote on passage of the resolution.
