UNANIMOUS CONSENT AGREEMENTS**S. RES. 195**

1.—*Ordered*, That on Thursday, May 15, 2025, following disposition of the Donahue nomination, the Senate resume Legislative Session and the Senator from Virginia (Mr. Kaine) or his designee be recognized to make a motion to discharge the Committee on Foreign Relations from further consideration of S. Res. 195, a resolution requesting information on El Salvador's human rights practices pursuant to section 502B(c) of the Foreign Assistance Act of 1961; provided, that following the motion to discharge, all time until 1:45 p.m. be equally divided and the Senate then vote on the motion to discharge S. Res. 195. (*May 14, 2025.*)

S. 1582 (ORDER NO. 66)

2.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 1582, a bill to provide for the regulation of payment stablecoins, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*May 8, 2025.*)
