UNANIMOUS CONSENT AGREEMENTS

H.R. 5371 (ORDER NO. 168)

1.—*Ordered*, That on Thursday, October 16, 2025, notwithstanding Rule XXII, the motion to invoke cloture on the motion to proceed to H.R. 5371, an Act making continuing appropriations and extensions for the fiscal year 2026, and for other purposes, ripen at 11:00 a.m.

Ordered further, That with respect to the entered motion to invoke cloture on the motion to proceed to H.R. 5371, filed on October 9, 2025, the mandatory quorum call under Rule XXII be waived. (*Oct. 14, 15, 2025.*)

H.R. 4016 (ORDER NO. 136)

2.—*Ordered*, That on Thursday, October 16, 2025, notwithstanding Rule XXII, the motion to invoke cloture on the motion to proceed to H.R. 4016, an Act making appropriations for the Department of Defense for the fiscal year ending September 30, 2026, and for other purposes, ripen at 1:30 p.m. (*Oct. 15, 2025.*)

S. 2882 (ORDER NO. 167)

3.—*Ordered*, That with respect to the entered motion to reconsider the motion to invoke cloture on the motion to proceed to S. 2882, a bill making continuing appropriations for the fiscal year ending September 30, 2026, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*Oct. 9, 2025.*)

S.J. RES. 77 AND S.J. RES. 81

4.—*Ordered*, That notwithstanding Rule XXII, at a time to be determined by the Majority Leader, following consultation with the Democratic Leader, and no later than Friday, October 31, 2025, it be in order to discharge the Committee on Finance of S.J. Res. 77, a joint resolution terminating the national emergency declared to impose duties on articles imported from Canada, and S.J. Res. 81, a joint resolution terminating the national emergency declared to impose duties on articles imported from Brazil, individually, and the Senate proceed to its consideration; provided, that there be up to six hours for debate only on each joint resolution, with the time equally divided between the Leaders or their designees; provided further, that following the use or yielding back of that time, each joint resolution be read a third time, and the Senate vote on passage of the joint resolution. (*Oct. 7, 2025.*)

S. 2806 (ORDER NO. 161)

5.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 2806, a bill to provide for automatic continuing appropriations, the mandatory quorum call under Rule XXII be waived. (*Sept. 29, 2025.*)
