UNANIMOUS CONSENT AGREEMENTS

S. 3012 (ORDER NO. 191)

1.—*Ordered*, That with respect to the entered motion to reconsider the motion to invoke cloture on the motion to proceed to S. 3012, a bill to appropriate funds for pay and allowances of excepted Federal employees for periods of work performed during a lapse in appropriations, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*Oct. 23, 2025.*)

H.R. 5371 (ORDER NO. 168)

2.—*Ordered further*, That with respect to the entered motions to reconsider the votes on the motions to invoke cloture on the motion to proceed to H.R. 5371, filed on October 9, 14, 16, 20, 2025, the mandatory quorum calls under Rule XXII be waived. (*Oct. 14, 16, 20, 21, 22, 2025.*)

S.J. RES. 88

3.—*Ordered*, That, notwithstanding Rule XXII, at a time to be determined by the Majority Leader following consultation with the Democratic Leader, and not later than Friday, October 31, 2025, it be in order to discharge the Committee on Finance from further consideration of S.J. Res. 88, a joint resolution terminating the national emergency declared to impose global tariffs, and the Senate proceed to its consideration; provided, that there be up to 6 hours for debate only on the joint resolution, with the time equally divided between the two Leaders or their designees, and upon the use or yielding back of time, the joint resolution be considered read a third time and the Senate vote on passage of the joint resolution. (*Oct. 22, 2025.*)

H.R. 4016 (ORDER NO. 136)

4.—*Ordered*, That with respect to the entered motion to reconsider the motion to invoke cloture on the motion to proceed to H.R. 4016, an Act making appropriations for the Department of Defense for the fiscal year ending September 30, 2026, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*Oct. 16, 2025.*)

S. 2882 (ORDER NO. 167)

5.—*Ordered*, That with respect to the entered motion to reconsider the motion to invoke cloture on the motion to proceed to S. 2882, a bill making continuing appropriations for the fiscal year ending September 30, 2026, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*Oct. 9, 2025.*)

S.J. RES. 77 AND S.J. RES. 81

6.—*Ordered*, That notwithstanding Rule XXII, at a time to be determined by the Majority Leader, following consultation with the Democratic Leader, and no later than Friday, October 31, 2025, it be in order to discharge the Committee on Finance of S.J. Res. 77, a joint resolution terminating the national emergency declared to impose duties on articles imported from Canada, and S.J. Res. 81, a joint resolution terminating the national emergency declared to impose duties on articles imported from Brazil, individually, and the Senate proceed to its consideration; provided, that there be up to six hours for debate only on each joint resolution, with the time equally divided between the Leaders or their designees; provided further, that following the use or yielding back of that time, each joint resolution be read a third time, and the Senate vote on passage of the joint resolution. (*Oct. 7, 2025.*)

S. 2806 (ORDER NO. 161)

7.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 2806, a bill to provide for automatic continuing appropriations, the mandatory quorum call under Rule XXII be waived. (*Sept. 29, 2025.*)
