UNANIMOUS CONSENT AGREEMENTS**H.R. 5371 (ORDER NO. 168)**

1.—*Ordered further*, That with respect to the entered motions to reconsider the votes on the motions to invoke cloture on the motion to proceed to H.R. 5371, filed on October 14, 16, 20, 2025, the mandatory quorum calls under Rule XXII be waived. (*Oct. 16, 20, 21, 22, 2025.*)

S. 3012 (ORDER NO. 191)

2.—*Ordered*, That with respect to the entered motion to reconsider the motion to invoke cloture on the motion to proceed to S. 3012, a bill to appropriate funds for pay and allowances of excepted Federal employees for periods of work performed during a lapse in appropriations, and for other purposes, the mandatory quorum call under Rule XXII be waived.
