UNANIMOUS CONSENT AGREEMENTS**H.R. 5371 (ORDER NO. 168)**

1.—*Ordered*, That on Tuesday, November 4, 2025, the motion to invoke cloture on the motion to proceed to H.R. 5371, an Act making continuing appropriations and extensions for fiscal year 2026, and for other purposes, filed on October 30, 2025, ripen at 11:30 a.m.; provided, that with respect to the entered motions to reconsider the votes on the motions to invoke cloture on the motion to proceed to H.R. 5371, filed on October 14, 16, 20, 2025, the mandatory quorum calls under Rule XXII be waived. (*Oct. 16, 20, 22; Nov. 3, 2025.*)

S. 3012 (ORDER NO. 191)

2.—*Ordered*, That with respect to the entered motion to reconsider the motion to invoke cloture on the motion to proceed to S. 3012, a bill to appropriate funds for pay and allowances of excepted Federal employees for periods of work performed during a lapse in appropriations, and for other purposes, the mandatory quorum call under Rule XXII be waived.
