UNANIMOUS CONSENT AGREEMENTS**S.J. RES. 90**

1.—*Ordered*, That, on Thursday, November 6, 2025, if the Senator from Virginia (Mr. Kaine) makes a motion to discharge S.J. Res. 90, a joint resolution to direct the removal of United States Armed Forces from hostilities within or against Venezuela that have not been authorized by Congress, the Senate vote on the motion at 5:00 p.m. (*Nov. 5, 2025.*)

H.R. 5371 (ORDER NO. 168)

2.—*Ordered*, That with respect to the entered motions to reconsider the votes on the motions to invoke cloture on the motion to proceed to H.R. 5371, an Act making continuing appropriations and extensions for fiscal year 2026, filed on October 14, 16, 20, 2025, the mandatory quorum calls under Rule XXII be waived. (*Oct. 16, 20, 22; 2025.*)

S. 3012 (ORDER NO. 191)

3.—*Ordered*, That with respect to the entered motion to reconsider the motion to invoke cloture on the motion to proceed to S. 3012, a bill to appropriate funds for pay and allowances of excepted Federal employees for periods of work performed during a lapse in appropriations, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*Oct. 23, 2025.*)

H.R. 4016 (ORDER NO. 136)

4.—*Ordered*, That with respect to the entered motion to reconsider the motion to invoke cloture on the motion to proceed to H.R. 4016, an Act making appropriations for the Department of Defense for the fiscal year ending September 30, 2026, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*Oct. 16, 2025.*)

S. 2882 (ORDER NO. 167)

5.—*Ordered*, That with respect to the entered motion to reconsider the motion to invoke cloture on the motion to proceed to S. 2882, a bill making continuing appropriations for the fiscal year ending September 30, 2026, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*Oct. 9, 2025.*)

S. 2806 (ORDER NO. 161)

6.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 2806, a bill to provide for automatic continuing appropriations, the mandatory quorum call under Rule XXII be waived. (*Sept. 29, 2025.*)
