**UNANIMOUS CONSENT AGREEMENTS**

H.R. 5371 (ORDER NO. 168)

1.—*Ordered*, That with respect to the entered motions to reconsider the votes on the motions to invoke cloture on the motion to proceed to H.R. 5371, an Act making continuing appropriations and extensions for fiscal year 2026, filed on October 14, 16, 20, 2025, the mandatory quorum calls under Rule XXII be waived.
