UNANIMOUS CONSENT AGREEMENTS

H.R. 4405

1.—*Ordered*, That, when the Senate receives H.R. 4405, an Act to require the Attorney General to release all documents and records in possession of the Department of Justice relating to Jeffrey Epstein, and for other purposes, from the House of Representatives, the Senate proceed to its immediate consideration, and the bill be considered read three times and passed with no intervening action or debate; provided, that the motion to reconsider be considered made and laid upon the table. (*Nov. 18, 2025.*)

H.R. 4016 (ORDER NO. 136)

2.—*Ordered*, That with respect to the entered motion to reconsider the motion to invoke cloture on the motion to proceed to H.R. 4016, an Act making appropriations for the Department of Defense for the fiscal year ending September 30, 2026, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*Oct. 16, 2025.*)

S. 2882 (ORDER NO. 167)

3.—*Ordered*, That with respect to the entered motion to reconsider the motion to invoke cloture on the motion to proceed to S. 2882, a bill making continuing appropriations for the fiscal year ending September 30, 2026, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*Oct. 9, 2025.*)

S. 2806 (ORDER NO. 161)

4.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 2806, a bill to provide for automatic continuing appropriations, the mandatory quorum call under Rule XXII be waived. (*Sept. 29, 2025.*)
