Res. 130, a joint resolution providing for congressional disapproval under chapter 8 of title 5, United States Code, of the rule submitted by the Bureau of Land Management relating to “Buffalo Field Office Record of Decision and Approved Resource Management Plan Amendment”; provided, that at 1:45 p.m., the joint resolution be considered read a third time and the Senate vote on passage of the joint resolution.
