## UNANIMOUS CONSENT AGREEMENTS

### S. 3386 (ORDER NO. 285)

1.—*Ordered*, That upon the expiration of the Morning Hour on Thursday, December 11, 2025, the Senate resume consideration of the motion to proceed to S. 3386, a bill to provide a health savings account contribution to certain enrollees, to reduce health care costs, and for other purposes; provided, that, notwithstanding Rule XXII, at 11:30 a.m., the Senate vote on the motion to invoke cloture on the motion to proceed. (*Dec. 10, 2025.*)

### S. 3385 (ORDER NO. 284)

2.—*Ordered*, That notwithstanding Rule XXII and upon the disposition of the cloture vote on the motion to proceed to S. 3386, on Thursday, December 11, 2025, the Senate vote on the motion to invoke cloture on the motion to proceed to S. 3385, a bill to amend the Internal Revenue Code of 1986 to extend the enhancement of the health care premium tax credit. (*Dec. 10, 2025.*)

### S.J. RES. 82 (ORDER NO. 203)

3.—*Ordered*, That all time be expired on S.J. Res. 82, a joint resolution providing for congressional disapproval under chapter 8 of title 5, United States Code, of the rule submitted by the Office of the Secretary of the Department of Health and Human Services relating to “Policy on Adhering to the Text of the Administrative Procedure Act,”; provided, that notwithstanding Rule XXII, at a time to be determined by the Majority Leader in consultation with the Democratic Leader, no later than Friday, December 19, 2025, the joint resolution be read a third time and the Senate vote on passage of the joint resolution. (*Dec. 10, 2025.*)

### H.R. 4016 (ORDER NO. 136)

4.—*Ordered*, That with respect to the entered motion to reconsider the motion to invoke cloture on the motion to proceed to H.R. 4016, an Act making appropriations for the Department of Defense for the fiscal year ending September 30, 2026, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*Oct. 16, 2025.*)

### S. 2882 (ORDER NO. 167)

5.—*Ordered*, That with respect to the entered motion to reconsider the motion to invoke cloture on the motion to proceed to S. 2882, a bill making continuing appropriations for the fiscal year ending September 30, 2026, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*Oct. 9, 2025.*)

### S. 2806 (ORDER NO. 161)

6.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 2806, a bill to provide for automatic continuing appropriations, the mandatory quorum call under Rule XXII be waived. (*Sept. 29, 2025.*)

When objection is heard to the second reading of a bill or joint resolution, that measure is then laid before the Senate during morning business of the next legislative day for the second reading. (Rule XIV, Paragraph 2.)
