UNANIMOUS CONSENT AGREEMENTS

H.R. 7148 (ORDER NO. 302)

1.—*Ordered*, That on Friday, January 30, 2026, upon the conclusion of Morning Business, the Senate resume consideration of the motion to proceed to H.R. 7148, an Act making further consolidated appropriations for the fiscal year ending September 30, 2026, and for other purposes; provided, that the mandatory quorum call under Rule XXII, with respect to the motion to invoke cloture on the motion to proceed, be waived. (*Jan. 29, 2026.*)

H.R. 4016 (ORDER NO. 136)

2.—*Ordered*, That with respect to the entered motion to reconsider the motion to invoke cloture on the motion to proceed to H.R. 4016, an Act making appropriations for the Department of Defense for the fiscal year ending September 30, 2026, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*Oct. 16, 2025.*)
