**UNANIMOUS CONSENT AGREEMENTS**

## H.J. RES. 142 (ORDER NO. 315)

1.—*Ordered*, That notwithstanding Rule XXII, on Thursday, February 12, 2026, upon the conclusion of Morning Business, the Senate resume consideration of H.J. Res. 142, a joint resolution disapproving the action of the District of Columbia Council in approving the D.C. Income and Franchise Tax Conformity and Revision Temporary Amendment Act of 2025, and the Senate vote on passage of the joint resolution at 12:00 noon. (*Feb. 11, 2026.*)

## H.R. 7147 (ORDER NO. 311)

2.—*Ordered*, That notwithstanding Rule XXII, on Thursday, February 12, 2026, following disposition of H.J. Res. 142, the Senate resume consideration of the motion to proceed to H.R. 7147, an Act making further consolidated appropriations for the fiscal year ending September 30, 2026, and for other purposes; provided, that there be 30 minutes of debate equally divided between the two Leaders or their designees and upon the use or yielding back of time the Senate vote on the motion to invoke cloture on the motion to proceed. (*Feb. 11, 2026.*)

## H.R. 4016 (ORDER NO. 136)

3.—*Ordered*, That with respect to the entered motion to reconsider the motion to invoke cloture on the motion to proceed to H.R. 4016, an Act making appropriations for the Department of Defense for the fiscal year ending September 30, 2026, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*Oct. 16, 2025.*)

## S. 2882 (ORDER NO. 167)

4.—*Ordered*, That with respect to the entered motion to reconsider the motion to invoke cloture on the motion to proceed to S. 2882, a bill making continuing appropriations for the fiscal year ending September 30, 2026, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*Oct. 9, 2025.*)

## S. 2806 (ORDER NO. 161)

5.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 2806, a bill to provide for automatic continuing appropriations, the mandatory quorum call under Rule XXII be waived. (*Sept. 29, 2025.*)
