UNANIMOUS CONSENT AGREEMENTS

H.R. 7147 (ORDER NO. 311)

1.—*Ordered*, That on Tuesday, February 23, 2026, the motion to invoke cloture on the motion to proceed to H.R. 7147, an Act making further consolidated appropriations for the fiscal year ending September 30, 2026, and for other purposes, presented on February 12, ripen at 5:30 p.m.; provided, that with respect to the motion to invoke cloture on the motion to proceed to H.R. 7147 presented on February 10, the mandatory quorum call under Rule XXII be waived.
