UNANIMOUS CONSENT AGREEMENTS

H.R. 6644 (ORDER NO. 343)

1.—*Ordered*, That on Monday, March 2, 2026, upon the conclusion of Morning Business, the Senate resume consideration of the motion to proceed to H.R. 6644, an Act to increase the supply of housing in America, and for other purposes; provided, the cloture motion with respect to the motion to proceed ripen at 5:30 p.m. (*Feb. 26, 2026.*)

H.R. 7147 (ORDER NO. 311)

2.—*Ordered*, That with respect to the motions to invoke cloture on the motion to proceed to H.R. 7147, an Act making further consolidated appropriations for the fiscal year ending September 30, 2026, and for other purposes, presented on February 10 and February 12, the mandatory quorum call under Rule XXII be waived. (*Feb. 12, 24, 2026.*)

H.R. 4016 (ORDER NO. 136)

3.—*Ordered*, That with respect to the entered motion to reconsider the motion to invoke cloture on the motion to proceed to H.R. 4016, an Act making appropriations for the Department of Defense for the fiscal year ending September 30, 2026, and for other purposes, the mandatory quorum call under Rule XXII be waived.
