UNANIMOUS CONSENT AGREEMENTS

H.R. 6644 (ORDER NO. 343)

1.—*Ordered*, That on Thursday, March 5, 2026, upon the conclusion of Morning Business, the Senate resume consideration of H.R. 6644, an Act to increase the supply of housing in America, and for other purposes. (*Mar. 4, 2026.*)

H.R. 7147 (ORDER NO. 311)

2.—*Ordered*, That with respect to the motions to invoke cloture on the motion to proceed to H.R. 7147, an Act making further consolidated appropriations for the fiscal year ending September 30, 2026, and for other purposes, presented on February 10 and February 12, the mandatory quorum call under Rule XXII be waived. (*Feb. 12, 24, 2026.*)

H.R. 4016 (ORDER NO. 136)
