**UNANIMOUS CONSENT AGREEMENTS**

H.R. 6644 (ORDER NO. 343)

1.—*Ordered*, That the filing deadline with respect to first degree amendments to Amdt. No. 4308, offered by the Senator from South Carolina (Mr. Scott), and H.R. 6644, an Act to increase the supply of housing in America, and for other purposes, be on Monday, March 9, 2026, at 3:30 p.m. (*Mar. 5, 2026.*)

H.R. 7147 (ORDER NO. 311)

2.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to H.R. 7147, an Act making further consolidated appropriations for the fiscal year ending September 30, 2026, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*Feb. 24, 2026.*)

H.R. 4016 (ORDER NO. 136)
