UNANIMOUS CONSENT AGREEMENTS**H.R. 6644 (ORDER NO. 343)**

1.—*Ordered*, That on Tuesday, March 10, 2026, at 2:15 p.m., the Senate resume Legislative Session and the cloture motion ripen with respect to Amdt. No. 4308, offered by the Senator from South Carolina (Mr. Scott), and H.R. 6644, an Act to increase the supply of housing in America, and for other purposes, and the Senate vote on the motion to invoke cloture.

Ordered further, That the filing deadline with respect to first degree amendments to Amdt. No. 4308, and H.R. 6644, be on Monday, March 9, 2026, at 3:30 p.m., and the filing deadline with respect to second degree amendments to Amdt. No. 4308, and H.R. 6644, be on Tuesday, March 10, 2026, at 12:00 noon. (*Mar. 5, 9, 2026.*)

H.R. 7147 (ORDER NO. 311)

2.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to H.R. 7147, an Act making further consolidated appropriations for the fiscal year ending September 30, 2026, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*Feb. 24, 2026.*)

H.R. 4016 (ORDER NO. 136)

3.—*Ordered*, That with respect to the entered motion to reconsider the motion to invoke cloture on the motion to proceed to H.R. 4016, an Act making appropriations for the Department of Defense for the fiscal year ending September 30, 2026, and for other purposes, the mandatory quorum call under Rule XXII be waived.
