UNANIMOUS CONSENT AGREEMENTS

H.R. 6644 (ORDER NO. 343)

1.—*Ordered*, That on Thursday, March 12, 2026, upon the conclusion of Morning Business, the Senate resume consideration of H.R. 6644, an Act to increase the supply of housing in America, and for other purposes; provided, at 11:30 a.m., the bill, as amended, be read a third time and the Senate vote on passage of the bill, as amended.

Ordered further, That the filing deadline with respect to first degree amendments to H.R. 6644, be on Monday, March 9, 2026, at 3:30 p.m., and the filing deadline with respect to second degree amendments to H.R. 6644, be on Tuesday, March 10, 2026, at 12:00 noon. (*Mar. 5, 9, 11, 2026.*)

H.R. 7147 (ORDER NO. 311)

2.—*Ordered*, That notwithstanding Rule XXII, on Thursday, March 12, 2026, at 1:45 p.m., the motion to invoke cloture on the motion to proceed to H.R. 7147, an Act making further consolidated appropriations for the fiscal year ending September 30, 2026, and for other purposes, presented on March 10, ripen; provided, that with respect to the motion to invoke cloture on the motion to proceed to H.R. 7147, presented on February 12, the mandatory quorum call under Rule XXII be waived. (*Feb. 24, Mar. 10, 2026.*)

H.R. 4016 (ORDER NO. 136)

3.—*Ordered*, That with respect to the entered motion to reconsider the motion to invoke cloture on the motion to proceed to H.R. 4016, an Act making appropriations for the Department of Defense for the fiscal year ending September 30, 2026, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*Oct. 16, 2025.*)

S. 2882 (ORDER NO. 167)

4.—*Ordered*, That with respect to the entered motion to reconsider the motion to invoke cloture on the motion to proceed to S. 2882, a bill making continuing appropriations for the fiscal year ending September 30, 2026, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*Oct. 9, 2025.*)

S. 2806 (ORDER NO. 161)

5.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 2806, a bill to provide for automatic continuing appropriations, the mandatory quorum call under Rule XXII be waived. (*Sept. 29, 2025.*)
