UNANIMOUS CONSENT AGREEMENTS

HOUSE MESSAGE TO ACCOMPANY S. 1383

1.—*Ordered*, That on Thursday, March 19, 2026, upon the conclusion of Leader remarks, the Senate resume consideration of the House Message with respect to S. 1383, an Act to establish the Veterans Advisory Committee on Equal Access, and for other purposes. (*Mar. 18, 2026.*)

H.R. 7147 (ORDER NO. 311)

2.—*Ordered*, That with respect to the motions to invoke cloture on the motion to proceed to H.R. 7147, an Act making further consolidated appropriations for the fiscal year ending September 30, 2026, and for other purposes, presented on February 12 and March 10, the mandatory quorum call under Rule XXII be waived. (*Feb. 24, Mar. 12, 2026.*)

H.R. 4016 (ORDER NO. 136)

3.—*Ordered*, That with respect to the entered motion to reconsider the motion to invoke cloture on the motion to proceed to H.R. 4016, an Act making appropriations for the Department of Defense for the fiscal year ending September 30, 2026, and for other purposes, the mandatory quorum call under Rule XXII be waived.
