**UNANIMOUS CONSENT AGREEMENTS**

S. 4784 (ORDER NO. 436)

1.—*Ordered*, That, notwithstanding Rule XXII, cloture on the motion to proceed to S. 4784, an original bill to authorize appropriations for fiscal year 2027 for military activities of the Department of Defense, for military construction, and for defense activities of the Department of Energy, to prescribe military personnel strengths for such fiscal year, and for other purposes, ripen following disposition of the Schwartz nomination on July 14, 2026. (*June 24, 2026.*)

H.R. 4016 (ORDER NO. 136)

2.—*Ordered*, That with respect to the entered motion to reconsider the motion to invoke cloture on the motion to proceed to H.R. 4016, an Act making appropriations for the Department of Defense for the fiscal year ending September 30, 2026, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*Oct. 16, 2025.*)

S. 2882 (ORDER NO. 167)

3.—*Ordered*, That with respect to the entered motion to reconsider the motion to invoke cloture on the motion to proceed to S. 2882, a bill making continuing appropriations for the fiscal year ending September 30, 2026, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*Oct. 9, 2025.*)

S. 2806 (ORDER NO. 161)

4.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 2806, a bill to provide for automatic continuing appropriations, the mandatory quorum call under Rule XXII be waived. (*Sept. 29, 2025.*)
