JESSE BROWN, Secretary of Veterans Affairs; born in Detroit, MI, March 27, 1944; served in U.S. Marine Corps, 1963-65, injured in Vietnam in 1965; A.A., Chicago City College, 1972; national service officer, Disabled American Veterans (DAV), 1967-73; supervisor, national service officer, DAV, 1973-76; supervisor, National Appeals Office, DAV, 1976-81; deputy national service director, 1981-88; executive director, Washington office, DAV, 1988-93; chosen by President-elect Clinton as Secretary of Veterans Affairs-designate on December 17, 1992; nominated by President Clinton on January 20, 1993; confirmed by the U.S. Senate on January 21, 1993; sworn in on January 22, 1993.
