JOHN WHITE, Deputy Secretary of Defense, nominated by President William Clinton; confirmed by the U.S. Senate and sworn in on June 22, 1995; M.A. and Ph.D. in economics from the Maxwell Graduate School at Syracuse University, and a B.S. in industrial and labor relations from Cornell University; most recently served as the chairman of the Commission on Roles and Missions for the Armed Forces; served as director of the Center for Business and Government at the Kennedy School of Government at Harvard University; general manager of the Integration and Systems Products Division and vice president of the Eastman Kodak Company (1988-92); CEO and chairman of the board of Interactive Systems Corporation (1981-88); deputy director of the Office of Management and Budget (1978-81); Assistant Secretary of Defense for Manpower, Reserve Affairs and Logistics (1977-78); senior vice president, Rand Corporation (1968-77).
