With the addition of biographical sketches of legislators in 1867, the Congressional Directory attained its modern format.

The Congressional Directory is published by the United States Senate in partnership with the Government Printing Office, at the direction of the Joint Committee on Printing under the authority of Title 44, Section 721 of the U.S. Code.
