LUGAR**, Republican, of Indianapolis, IN; born in Indianapolis, April 4, 1932; education: graduated, Shortridge High School, valedictorian, 1950; B.A., Denison University, Granville, OH, valedictorian, 1954; Rhodes Scholar, B.A., M.A., Pembroke College, Oxford, England, 1956; professional: served in the U.S. Navy, 1957–60; businessman; president and treasurer, Lugar Stock Farms, Inc., a grain operation and tree farm; vice president and treasurer, Thomas L. Green and Co., manufacturers of food production machinery, 1960–67; member, Indianapolis Board of School Commissioners, 1964–67; mayor of Indianapolis, 1968–75; member, advisory board, U.S. Conference of Mayors, 1969–75; National League of Cities, advisory council, 1972–75, president, 1971; Advisory Commission on Intergovernmental Relations, 1969–75, vice chairman, 1971–75; board of trustees, Denison University; Phi Beta Kappa; 44 honorary degrees; member, St. Luke's Methodist Church; married the former Charlene Smeltzer, 1956; four sons and thirteen grandchildren; committees: Agriculture, Nutrition, and Forestry; Foreign Relations; elected to the U.S. Senate on November 2, 1976, sworn in on January 3, 1977 as the 1,705th Senator; reelected to each succeeding Senate term.
