TIM SCOTT, Republican, of North Charleston, SC; born in North Charleston, September 19, 1965; education: R.B. Stall High School; B.S., Charleston Southern University, Charleston, SC, 1988; professional: former owner of Tim Scott Allstate and partner of Pathway Real Estate Group; served on Charleston County Council, 1995–2008; four terms as chair of the Charleston County Council; member of the South Carolina State House of Representatives, 2009–10; committees: ranking member, Special Committee on Aging; Banking, Housing, and Urban Affairs; Finance; Health, Education, Labor, and Pensions; Small Business and Entrepreneurship; elected to the 112th Congress on November 2, 2010; reelected to the 113th Congress on November 6, 2012; appointed by the Governor, January 2, 2013, to fill the vacancy caused by the resignation of Senator James DeMint; appointment took effect upon his resignation from the House of Representatives on January 2, 2013; took the oath of office on January 3, 2013; elected, by special election, on November 4, 2014, for the final two years of Senator DeMint's second term; reelected to the U.S. Senate on November 8, 2016.
