SIR: In accordance with provisions of P.L. 106-79, the Department of Defense Appropriations Act, 2000, I hereby request the following:

These resources will be used to fund costs associated with increased military pay and retirement benefits.

Finally, as directed by P.L. 106-79 and in accordance with provisions of P.L. 105-277, the Omnibus Consolidated and Emergency Supplemental Appropriations Act, 1999, I hereby request the following:

Procurement, Other procurement, Air Force	102,000,000
Procurement, Procurement, Defense-wide	100,000,000

These funds will support critical national security activities.

I hereby designate all of the above requests as emergency requirements pursuant to section 251(b)(2)(A) of the Balanced Budget and Emergency Deficit Control Act of 1985, as amended.

The details of these actions are set forth in the enclosed letter from the Director of the Office of Management and Budget. I concur with his comments and observations.

Submitted for your consideration are requests to make available a total of \$9,315.4 million in previously appropriated contingent emergency funds for the Department of Defense (DOD).

These requests include the following:

Operation and Maintenance (O&M). Section 8173 of P.L. 106-79, the Department of Defense Appropriations Act, 2000, provided \$7,200.0 million for O&M activities, contingent upon the President submitting a budget request for \$7,200.0 million to the Congress and designating the entire amount as an emergency requirement. This request would make these funds available to DOD to support training, maintenance, and other ongoing military operations.

Military Personnel. Section 2012 of P.L. 106-31, the 1999 Emergency Supplemental Appropriations Act, provided \$1,838.4 million in FY 2000 emergency funding for military personnel, contingent upon the President submitting a budget request for \$1,838.4 million to the Congress and designating the entire amount as an emergency requirement. This proposal would make these resources available to fund military pay and retirement programs, including the pay increase from 4.4 percent to 4.8 percent.

Classified Activities. P.L. 105-277, the Omnibus Consolidated and Emergency Supplemental Appropriations Act, 1999, provided \$1,496.6 million in emergency fund for defense-wide operation and maintenance activities, contingent upon the President submitting a budget request to the Congress and designating the entire amount requested as an emergency requirement. To date, \$937.4 million of that amount has been designated for such activities, leaving a balance of \$559.2 million. P.L. 106-79 directed that the Administration use \$277.0 million of the remaining contingent emergency funding for alternative purposes, which are identified in accompanying classified annexes.

I recommend that you designate the entire \$9,315.4 million as emergency requirements in accordance with section 251(b)(2)(A) of the Balanced Budget and Emergency Deficit Control Act of 1985, as amended. No further congressional action will be required.

I have carefully reviewed these proposals and am satisfied that they are necessary at this time. Therefore, I join the Secretary of Defense in recommending that you make the requested funds available by signing the enclosed letter to the Speaker of the House of Representatives.

Section 8173 of P.L. 106-79, the Department of Defense Appropriations Act for FY 2000, provided \$7,200.0 million in emergency funding to DOD for operation and maintenance activities, contingent upon the President submitting a budget request to the Congress for \$7,200.0 million and designating the entire amount as an emergency requirement.

This contingent emergency funding is now required to be made available to the Operation and Maintenance accounts listed above and will be used to fund training events, maintenance activities, and other ongoing operations within DOD.

Section 2012 of P.L. 106-31, the FY 1999 Emergency Supplemental Appropriations Act, provided \$1,838.4 million in emergency funding to DOD to fund costs associated with increased military pay and retirement benefits in FY 2000, contingent upon the President submitting a budget request to the Congress for \$1,838.4 million and designating the entire amount as an emergency requirement.

This contingent emergency funding is now required to be made available to the Military Personnel accounts listed above.

Division B, Title I, Chapter 1 of P.L. 105-277, the FY 1999 Omnibus Consolidated and Emergency Supplemental Appropriations Act provided \$1,496.6 million in emergency funding for defense-wide operation and maintenance activities, contingent upon the President submitting a budget request to the Congress and designating the entire amount requested as an emergency requirement. To date, \$937.4 million of that amount has been designated as emergency requirements in support of various national security programs, leaving a balance of \$559.2 million.

P.L. 106-79 included provisions that directed \$277.0 million of the \$559.2 million balance to be made available for specific national security activities in the amounts listed above.
