The SPEAKER OF THE HOUSE OF REPRESENTATIVES.

SIR: In accordance with provisions of Public Law 105-277, the Omnibus Consolidated and Emergency Supplemental Appropriations Act, 1999, I hereby request the following transfer from the Information Technology Systems and Security Transfer Account:

This funding will support the Department of Defense's Year 2000 compliance activities.

I hereby designate all of the above requests as emergency requirements pursuant section 251(b)(2)(A) of the Balanced Budget and Emergency Deficit Control Act of 1985, as amended.

The details of these actions are set forth in the enclosed letter from the Department of Labor Office of Management and Budget. I concur with his comments and observations.

Submitted for your consideration are requests to transfer \$935 million from the Information Technology Systems and Security Transfer Account for Year 2000 (Y2K) compliance to 17 accounts in the Department of Defense (DOD).

Public Law 105-277, the Omnibus Consolidated and Emergency Supplemental Appropriations Act, 1999, provided contingent emergency funding totaling \$3.35 billion—\$1.1 billion for defense-related activities and \$2.25 billion for non-defense activities—to address Y2K. This is the first release of defense-related funding. Eighty-five percent is being released and fifteen percent will remain in reserve for emerging needs. As specified in P.L. 105-277, funding would only be transferred to accounts in previously enacted Department of Defense Appropriations Acts. To date, \$1.5 billion has been allocated for non-defense activities. OMB continues its oversight of Y2K-related activities Government-wide, and is working to ensure that agencies have sufficient FY 1999 resources available to address known requirements, retain some flexibility to address emerging needs, and most importantly, remain on schedule to achieve Y2K compliance.

The requested transfers will support a range of activities to ensure that critical DOD systems will operate smoothly through the Year 2000 and beyond, including operational evaluations, end-to-end testing, integration testing, and contingency planning and implementation. The funds will be transferred from the Information Technology Systems and Security Transfer Account. No further congressional action will be required.

Pursuant to the requirements of Public Law 105-277, on January 25, 1999, the Defense Department submitted a report to Congress on its proposed allocation and plan to achieve Y2K compliance for technology information systems.

I recommend that you designate the amounts listed on the enclosure as emergency requirements in accordance with section 251(b)(2)(A) of the Balanced Budget and Emergency Deficit Control Act of 1985, as amended.

I have carefully reviewed these proposals and am satisfied that they are necessary at this time. Therefore, I join the Secretary of Defense in recommending that you make the requested funds available by signing the enclosed letter to the Speaker of the House of Representatives.
