OPENING STATEMENT OF HON. BRYAN STEIL, CHAIRMAN OF THE COMMITTEE ON HOUSE ADMINISTRATION, A U.S. REPRESENTATIVE FROM WISCONSIN

Chairman STEIL. The Committee on House Administration will come to order. I note that a quorum is present.

Without objection, the chair is authorized to declare a recess at any time.

I would like to start by thanking Ranking Member Morelle and Members for participating in the two-part Committee funding hearing in recent weeks. The hearing with the chairs and Ranking Members of each House Committee took great effort and coordination. I am grateful to all the Members for your participation.

In the end, we heard from pretty much every chair and Ranking Member of the House Committees on their requested budgets for the 119th Congress.

Holding these hearings is one of the Committee's core responsibilities, and I believe these hearings advance our efforts to be more transparent and accountable to the American people.

In reviewing each of the budget requests, we wanted to ensure that every Committee has the necessary resources to execute their mission without wasting taxpayer dollars, which I believe we achieved with my Chairman's mark.

The amendment in the nature of a substitute provides Committees with the funding they need to conduct their important work in the 119th Congress. I am hopeful we can pass this resolution today to allow the Committees to get to work.

Today we will also be considering a Committee resolution setting the intern allocation for the standing and select committees, excluding the Appropriations Committee.

Internship opportunities on the Hill provide students and young adults an opportunity to see Government in action.

We will also be considering a resolution to establish an allocation for Committees' franked mail.

Finally, as our Committee oversees Federal elections, we will be considering five resolutions to dismiss election challenges from across the country.

I thank my colleagues for being here today, and I am hopeful we will pass all of these resolutions in a nonpartisan fashion.

I will now recognize the Ranking Member, Mr. Morelle, for 5 minutes for the purpose of offering an opening statement.

OPENING STATEMENT OF HON. JOSEPH MORELLE, RANKING MEMBER OF THE COMMITTEE ON HOUSE ADMINISTRATION, A U.S. REPRESENTATIVE FROM NEW YORK

Mr. MORELLE. Good afternoon. Thank you, Mr. Chairman.

Thank you for calling this meeting to consider, as you indicated, a number of important pieces of institutional legislation that enhance Committee capacity and protect one of the core constitutional responsibilities of the House.

As we recently established during our series of funding hearings, we must make sufficient investments in our Committees which allows them to hire and retain smart, dedicated staff and enables the execution of their respective missions under House rules.

This investment is particularly important as we enter a post-Chevron deference world of legislating and the burden of drafting and enacting technical and complicated regulations shifts from the executive branch to Congress and to our staffs from what I would charitably describe as a chaotic start to this administration.

We also have to ensure Committees are able to exercise rigorous and comprehensive oversight as we endeavor to maintain the separation of powers that our Federal Government is predicated upon. The omnibus Committee expense resolution we are considering today I believe accomplishes that.

While we are on the topic of Committee capacity building, we will also determine allocations for funding for Committee interns, as the chair just indicated, an important tool that provides personnel flexibility to Committees as we recruit and train the next generation of public servants.

Additionally, we will authorize financial allocations for official communications—or, as we refer to it here, franked mail—from Committees.

I do want to thank the chair for also docketing the dismissal of the five deficient and, in my view, frivolous election contests.

The Constitution vests the House with the ultimate determinative authority of who can be seated as a Member, and that responsibility is further bequeathed to this Committee by the Federal Contested Elections Act.

It is vitally important to the health of our democracy that we do not entertain contests that fall short of the requirements of the statute and dismiss them expeditiously.

With that, I do support the pieces of legislation on the agenda today. I urge my colleagues to do the same.

I want to thank the chair and the staffs on both sides for all their work.

With that, I yield back.

Chairman STEIL. The gentleman yields back.

I will now call up H. Res 198, providing for the expenses of certain Committees of the House of Representatives in the 119th Congress.

I want to thank again my colleagues for their cooperation on this important issue. By passing the resolution today, we will allow the Committees to begin their critical work in the 119th. I urge my colleagues to vote in favor of the resolution.

I again recognize the Ranking Member, Mr. Morelle, if you have an opening statement.

**Resolution to Approve Allocation from the Paid House
Committee Internship Program to Committees for 2025**

Be it resolved, that Public Law 117-103 provides an allowance separate from committee funds for compensation of interns and the Committee on House Administration determines the allocation of the allowance. The allowance for legislative year 2025 is \$2,600,000 which will be allocated as follows and distributed evenly among each committee between the majority and minority.

For these reasons, I urge my colleagues to support the resolutions to dismiss the election contests.

I will now recognize Ranking Member Morelle if you would like to offer an opening statement.

Mr. MORELLE. Yes. Thank you, Mr. Chairman. Very briefly.

The House is vested with the broad and comprehensive authority to establish the procedures and render final decisions relating to the election of its Members. The House has consistently and regularly exercised its authority from the very first Congress through the 118th Congress.

House Rule X and the Federal Contested Elections Act generally assign the Committee jurisdiction over contested elections. Today, the Committee acts pursuant to this authority to consider five resolutions and accompanying reports recommending the House dismiss various election contests before it.

Each of the contests is procedurally deficient in one form or another, and none provides evidence that the contestant has demonstrated a right to the seat.

I appreciate, Mr. Chairman, your work and your staff and their collaboration with our staff.

It is critical the House continue to play this role in a professional and bipartisan manner so the American people can be assured that their elective representatives are truly chosen by and for the people.

Accordingly, I support the resolutions and urge my colleagues to join me in voting yes.

With that, I thank you and yield back.
