(c)³ The compensation of Architect of the Capitol shall be at an annual rate which is equal to the rate for positions at level IV of such Executive Schedule.⁴

(d)⁵ The compensation of the Deputy Librarian of Congress and the Assistant Architect of the Capitol shall be at an annual rate which is equal to the rate for positions at level V of such Executive Schedule.

(e)⁶ The compensation of the Second Assistant Architect of the Capitol shall be at the rate of \$25,000 per annum.
