**Commerce, Justice, State, the Judiciary Appropriations, 1998:** Pursuant to the order of Thursday, July 24, 1997, Senate passed H.R. 2267, making appropriations for the Departments of Commerce, Justice, and State, the Judiciary, and related agencies for the fiscal year ending September 30, 1998, after striking all after the enacting clause and inserting in lieu thereof the text of S. 1022, Senate companion measure, as passed by the Senate on Tuesday, July 29, 1997, that the Senate insisted on its amendment, and the Chair appointed the following conferees on the part of the Senate: Senators Gregg, Stevens, Domenici, McConnell, Hutchison, Campbell, Cochran, Hollings, Byrd, Inouye, Bumpers, Lautenberg, and Mikulski. **Religious Workers Act:** Senate concurred in the amendments of the House to S. 1198, to amend the Immigration and Nationality Act to extend the special immigrant religious worker program, to amend the Illegal Immigration Reform and Immigrant Responsibility Act of 1996 to extend the deadline for designation of an effective date for paperwork changes in the employer sanctions program, and to require the Secretary of State to waive or reduce the fee for application and issuance of a nonimmigrant visa for aliens coming to the United States for certain charitable purposes, clearing the measure for the President.

**Motion to Instruct Conferees:** By a ye and nay vote of 412 yeas to 5 nays, Roll No. 480, agreed to the Doggett motion to instruct conferees on H.R. 1757, to consolidate international affairs agencies, to authorize appropriations for the Department of State and related agencies for fiscal years 1998 and 1999, to reject section 1601 of the Senate amendment, which provides for payment of all private claims against the Iraqi Government before those of U.S. veterans and the U.S. government (i.e., U.S. taxpayers). **Motion to Adjourn:** Rejected the Condit motion to adjourn by a recorded vote of 112 yeas to 295 noes, Roll No. 481. Pages H8279–80

**Antiquities Act:** The House agreed to H. Res. 256, as amended, the rule to provide for consideration of H.R. 1127, to amend the Antiquities Act to require an Act of Congress and the concurrence of the Governor and State legislature for the establishment by the President of national monuments in excess of 5,000 acres. Earlier, agreed to the Solomon amendment that makes in order an amendment to H.R. 1127 to be offered only by Representative Hansen or his designee. Pages H8278–85

**Six Month Extension of ISTEA:** Agreed by unanimous consent to consider H.R. 2516, to extend the Intermodal Surface Transportation Efficiency Act of

1991 through March 31, 1998, that an amendment to the bill be considered as adopted, and that the bill, as amended, be considered as passed. Pages H8285–90

**Motion to Adjourn:** Rejected the Nadler motion to adjourn by a ye-and-nay vote of 207 yeas to 213 noes, Roll No. 483. Pages H8291–92

**Sense of Congress Regarding the Ocean:** H. Con. Res. 131, amended, expressing the sense of Congress regarding the ocean (with 2/3 required for passage, failed to pass by a ye and nay vote of 237 yeas to 175 nays, Roll No. 484); Page H8293

**Coral Reef Conservation Act:** H.R. 2233, amended, to assist in the conservation of coral reefs (with 2/3 required for passage, failed to pass by a recorded vote of 230 yeas to 181 noes, Roll No. 485); Pages H8293–94

**Canadian River Reclamation Project, Texas:** H.R. 2007, amended, to amend the Act that authorized the Canadian River reclamation project, Texas, to direct the Secretary of the Interior to allow use of the project distribution system to transport water from sources other than the project (with 2/3 required for passage, failed to pass by a ye and nay vote of 226 yeas to 176 nays with 1 voting “present”, Roll No. 487); Pages H8295–96

**Miccosukee Settlement Act:** H.R. 1476, to settle certain Miccosukee Indian land takings claims within the State of Florida (with 2/3 required for passage, failed to pass by a ye and nay vote of 229 yeas to 176 nays, Roll No. 488); and **Pages H8296–97**

**Securities and Exchange Commission Authorization Act:** H.R. 1262, to authorize appropriations for the Securities and Exchange Commission for fiscal years 1998 and 1999 (with 2/3 required for passage, failed to pass by a ye and nay vote of 230 yeas to 170 nays, Roll No. 489). **Pages H8297–98**

Res. 151, amended, expressing the sense of the Congress that the United States should manage its public domain National Forests to maximize the reduction of carbon dioxide in the atmosphere among many other objectives and that the United States should serve as an example and as a world leader in actively managing its public domain national forests in a manner that substantially reduces the amount of carbon dioxide added to the atmosphere; H.R. 1856, amended, Volunteers for Wildlife Act of 1997; H.R. 2000, amended, to amend the Alaska Native Claims Settlement Act to make certain clarifications to the land bank protection provisions; H.R. 2259, King Cove Health and Safety Act of 1997; and H.R. 2402, amended, Water-Related Technical Corrections Act of 1997.

**AMERICAN LAND SOVEREIGNTY PROTECTION ACT**

*Committee on Rules:* Granted, by voice vote, a modified closed rule, providing 1 hour of debate on H.R.

901, American Land Sovereignty Protection Act. The rule makes in order the Committee on Resources amendment in the nature of a substitute as an original bill for the purpose of amendment, which shall be considered as read. The rule also makes in order an amendment to be offered by Representative Miller of California or his designee, which shall be considered as read, and shall be debatable for 60 minutes equally divided and controlled by the proponent and an opponent. The rule provides one motion to recommit, with or without instructions. Finally, the rule provides that House Resolution 243 is laid on the table.

**SPACE SHUTTLE SAFETY**

*Committee on Science:* Subcommittee on Space and Aeronautics held a hearing on Space Shuttle Safety.
