National Slavery and Trafficking Prevention Month: Senate agreed to S. Res. 382, supporting the goals and ideals of observing the National Slavery and Trafficking Prevention Month from January 1 through February 1, 2010, to raise awareness of, and opposition to, modern slavery. **Pages S13704–05**

National Mentoring Month: Senate agreed to S. Res. 383, designating January 2010 as “National Mentoring Month”. **Pages S13705–06**

A unanimous-consent-time agreement was reached providing for further consideration of the bill at approximately 7 a.m., on Tuesday, December 22, 2009, with post-cloture time continuing to run during the overnight adjournment; and the time until the expiration of post-cloture time be equally divided and controlled between the two Leaders, or their designees; that upon the expiration of time, the Majority Leader be recognized to move to table Reid Amendment No. 3278 (to the language proposed to be stricken by Amendment No. 2786) (listed above); that upon disposition of Reid Amendment No. 3278, that Reid Amendment No. 3277 (to Amendment No. 3276) (listed above), be withdrawn; that Senate then vote on adoption of Reid Amendment No. 3276 (to Amendment No. 2786) (listed above); that upon disposition of Reid Amendment No. 3276, Senate vote on the motion to invoke cloture on Reid Amendment No. 2786 (listed above); that if cloture is invoked, the Majority Leader then be

recognized, and the time until 9:30 a.m., then be equally divided and controlled between the two Leaders, or their designees; provided further, that the Senate begin alternating one hour blocks of time beginning at 9:30 a.m., until 5:30 p.m., with the Republicans controlling the first hour; that at 12:30 p.m., Senate stand in recess until 2:30 p.m., and that upon reconvening the Senate resume alternating blocks until 5:30 p.m., with all post-cloture time counting during any recess period and until 5:30 p.m.
