Rejected the Sean Patrick Maloney (NY) motion to recommit the bill to the Committee on Science, Space, and Technology with instructions to report the same back to the House forthwith with an amendment by a recorded vote of 195 ayes to 225 noes, Roll No. 524. **Pages H8062–63**

Pursuant to the Rule, the amendment in the nature of a substitute recommended by the Committee on Science, Space, and Technology now printed in the bill shall be considered as adopted. **Page H8050**

Agreed to:

Stewart amendment (No. 1 printed in part A of H. Rept. 113–626) that makes technical changes to conform with recent amendments to the underlying statute. It also reiterates the independence of the Science Advisory Board and clarifies pre-existing language (by a yea-and-nay vote of 232 yeas to 184 nays, Roll No. 523). **Pages H8060–62**
