**Carl Levin and Howard P. “Buck” McKeon National Defense Authorization Act:** By 89 yeas to 11

nays (Vote No. 325), Senate agreed to the motion to concur in the amendment of the House of Representatives to the amendment of the Senate to H.R. 3979, to authorize appropriations for fiscal year 2015 for military activities of the Department of Defense, for military construction, and for defense activities of the Department of Energy, to prescribe military personnel strengths for such fiscal year, by the order of the Senate of December 11, 2014, 60 Senators having voted in the affirmative, after taking action on the following motions and amendments proposed thereto:

By 18 yeas to 82 nays (Vote No. 323), Coburn Motion to refer the message of the House on the bill to the Committee on Armed Services, with instructions to report back forthwith with changes to strike Title XXX, the nondefense-related lands portion of the bill. (A unanimous-consent agreement was reached providing that the motion, having failed to achieve 60 affirmative votes, the motion was not agreed to.)

Subsequently, Senator Coburn motion to suspend Rule XXII for the purpose of proposing an amendment was rejected.
